Interconnection of Land Registers

- A single access point for searching and obtaining land property information from the land registers of Member States
 - Included in the European e-Justice Portal
- Users will be able to:
 - Search for titles, deeds, etc. for land properties
 - Buy relevant documentation
- within the Portal, in all EU languages.

Funding opportunities

- 2 Action Grants that include LRI:
 - 1. 2017 CEF Telecom call for proposals (deadline: 18 May)
 - 2. Action Grants for e-Justice projects (deadline: 11 July)
- Funding the interconnection of national LRs to LRI
- Both were circulated by emails to stakeholders, including ELRA.

State-of-play

- All technical documentation has been shared on CIRCABC (online platform)
 - incl. User Interface (UI)
 - Some feedback received → consolidation process
- Monthly tele-conference meetings
 - February / March 2017
 - Topics: feedback, state-of-play
 - All invited
- Construction of system has started



Next Steps

- Construction includes 3 feedback iterations:
 - 1 / month
 - 1-2 weeks of (remote) user testing of LRI with mock data
 - 1st iteration: June 2017
- Integration activities:
 - June 2017: Development of Integration tests
 - From June 2017: Availability for testing



Internal developments

- EC Project Manager (PM) will move post next week
- New PM will be assigned to LRI
 - Tentative timeline: 1-2 months
- During the transition, limited feedback from EC

 - NOT PM. Will not take decisions or progress project.
- IT contractor will continue work


