## PROPERTY REGISTER

- Registration of notary deed, not property rights
- Personal based registration information source for owners and property rights
- Property registration not systematically produced; sporadically created, only when have transaction with cadastral identifier (each property has a unique number identifier, given from the Cadastre agency)
- Registry agency
- is responsible for property register in Bulgaria
- have 113 regional registry offices, on court region base, covering all the country.
- receiving the documents at the front desk; entry judges check the documents and after their approval the data are entered into the information system.

## HOW WE ACCESS THE INFORMATION? \*\*\* HOW WE DELIVER THE INFORMATION? \*\*\*

- At the moment most of the services are required and provided only at the Registry Agency's offices
- Only Information is provided electronically through remote access to the web portal of Property Register: <a href="www.icadastre.bg">www.icadastre.bg</a>
- Registry agency upgrading the information system of the Property register, and latest 31.12.2020, most of the services will be accessed and provided by Unified portal for requesting electronic administrative services (UPRES).
- Integration with internal and external systems and registers, for automated data sending to the systems of other institutions.

#### WHAT INFORMATION PROPERTY REGISTER PROVIDE

All acts establishing, modifying or terminating a right of ownership or other right to real estate, for example:

- Sales, exchange, donation contracts
- Leases for a term longer than 1 year;
- Claims for real estate
- Judgments concerning real estate rights
- Foreclosures, mortgages, incorporation of a building right or other restricted right (such as a right of use)
- Other acts, which are provided by law, subject to entry in the Property Register
- Rejection of inheritance
- Announced wills regarding real estate rights
- Contribution of immovable assets in a commercial enterprise, etc.




