What is the EJN?

- A flexible, non-bureaucratic network of national judicial authorities.
 - *Simplifying judicial cooperation,*
 - *Providing assistance to legal professionals,*
 - *Ensuring a uniform understanding of EU law.*
- The EJN-civil operates since 2002.
- One of the most accessible tool to efficient implementation of EU law.

EJN's structure

- The EJN is composed of at least one point of contact per Member State
 - A judge and/or
 - A civil servant
 - At the federal and state level when necessary

EJN's structure

- The EJN is composed of more than 500 members:
 - *contact points,*
 - *central bodies and central authorities provided for in European and International legal acts,*
 - *liaison magistrates where they have responsibilities in this field of law,*
 - *associations of legal professions,*
 - *any other appropriate judicial or administrative authorities (in civil justice matters).*

EJN's tasks

The EJM Decision outlines the following tasks:

- *Facilitating judicial cooperation,*
- *Facilitating access to justice,*
- *Facilitating the operation of cross-border procedures,*
- *Facilitating the operation of EU law instruments,*
- *Establishing an information system relevant to the above.*

Resolving problems

1) *Through day to day cooperation between the members:*

- *Supply other CPs and authorities with information needed for judicial cooperation,*
- *Supply information on foreign law,*
- *Seek solutions to concrete cases,*

Resolving problems

2) *Through the organisation of meetings:*

- Plenary meetings,
- Bilateral meetings,
- Working group meetings,
- Cooperation with other networks (EJN-criminal, EJTN, CCBE, MyEurope, etc...),
- National judicial cooperation networks;

Resolving problems

3) Making available of information on judicial cooperation and facilitating access to justice :

- *guides,*
- *forms*
- *factsheets*

Guides

- Guides to EU law instruments produced by the EJN,
- 15 guides in the form of publications and one guide integrated in the dynamic forms on maintenance are currently available through the European eJustice Portal,
- Produced by EJN working groups both for practitioners and citizens,

Guidance

- - EJN also produces voluntary tools (not mandated by the acquis, but serving a practical purpose):
 - Art. 26 (2) Brussels I recast,
 - Information to be provided by the court to a party on its right to contest the court's jurisdiction,
 - Maintenance Obligations,
 - Arrears calculation form
 - Upcoming form on the obtaining of information on the debtor in European Account Preservation Order cases,
