WHO DOES WHAT?

- No notaries •
- The parties may draw up the legal documents themselves •
- Application for registration can be made by the applicant personally
- Most applications are made by banks as representatives for ٠ the applicants
- Especially if the buyer needs a loan ٠
- Land registration authority performs a mainly formal control •

- No ID-control and no required permit for foreigners •
- One formal procedure



- Help and learn from each other
















Environmental information

In 2021, I participated in a meeting about climate adaptation and legislation that affect Lantmäteriet

There is little information about the environment in the land register today

I mentioned ELRA's discussions in various ELRN - workshops and IMOLA - workshops

Result

A pre-study about information in the land register concerning risks of natural disasters such as landslides, flooding etc.

A pilot where Lantäteriet and other Swedish authorities discuss if and how environmental information could be gathered and centralized in the future

GREAT ECONOMIC VALUES

All transfers regarding immovable properties in Sweden are handled in Lantmäteriet's systems

- Sweden's immovable propertes are valued at 1,61 trillion euro
- About 1/3 of all moneylaundering in Sweden is estimated to be connected with immovable properties

CURRENT STATUS


- Lantmäteriet has no crime preventing tasks or obligations today
- We are since 2022 one of several networking authorities, collaborating with the Swedish police
- Lantmäteriet participates in different state investigations on the subject
- An increased focus on Lantmäteriets information and how it can contribute in crime investigations and crime prevention
- We have taken part in a few pilot activities with the police



GOVERNMENT ASSIGNMENT - FI2022 / 02443

The government has assigned Lantmäteriet to investigate

- If and how the authority, based on current technical and legal conditions, can contribute to prevent and counteract crime that is connected with immovable properties, for example money laundering, fraud and organized crime
- What measures the authority could take if the legal and technical conditions were changed
- The assigned investigation ends by the 31st of May 2023
- ELRA has been an inspiration




SOME CONCLUSIONS SO FAR

- Lantmäteriet has information that is valuable for law enforcing agencies as well as crime preventing authorities
- The demand for our information and professional knowledge has increased
- Lantmäteriet wants to take a bigger responsibility in supporting law enforcing and crime preventing authorities
- Legislative measures are required
- Crime prevention should be formal task for Lantmäteriet
- Such a task requires additional funding and resources
- Increased cooperation and united actions are crucial for success
- ELRA is mentioned in the report
- Sweden now tries to inspire our nordic countries (Nordic collaboration)
