## **XXXIII General Assembly**

#### **20 Years of Commitment**

On **November 6th**, the **XXXIII ELRA General Assembly** took place in Brussels in a hybrid format, celebrating two decades of of ELRA's commitment to legal security and registry collaboration across Europe.

The event gathered a total of 70 representatives from member organizations across Europe as well as prominent figures from European Commission, judges, university academics, and representatives from leading associations within the European and legal landscape.



The Assembly began with an opening speech by ELRA President, **Mr. Mihai Taus**, who highlighted the association's ongoing contribution to the improvement of transnational legal cooperation.

Following, **Mrs. Ana Gallego**, Director-General, DG Justice, European Commission, emphasized the crucial role ELRA plays in strenghening judicial cooperation, highlighting the collaborative mechanisms that ELRA has developed over the past 20 years.

## **IMOLA IV Kick-off Conference**

The IMOLA IV project commenced on 1 August 2024 and will be developed over the subsequent 24 months. The project was inaugurated with a kick-off conference held on 5 November in Brussels, conducted in a hybrid format.

IMOLA IV, which is funded under the Civil Justice Programme of the European Commission, represents the continuation of the MOLA I, II and III Projects. The project's primary objective is to enhance the quantity, quality, and accessibility of the Knowledge Organization System (KOS) developed for European property registry connection and harmonisation of juridical information.

# **European Parliament approves the "von der Leyen II" Commission**

## The New College of Commissioners will take office on 1 December

This decision paves the way for a new team of commissioners who will work on pressing issues such as tackling climate change, accelerating digital innovation, fostering economic resilience, and stengthening the European Union's role on the global stage.

The Commission's agenda includes bold commitment to achieving carbon neutrality, advancing social inclusion, and boosting competitiveness while adhering to democracy values. This moment underscores the EU's commitment to addressing the challenges of the modern era with renewed vigor and unity. The Parliament's endorsement marks a significant step forward for the EU's strategic agenda for the next five yeas.

The European Parliament has officially approved Ursula von der Leyen's second European Commission, which will lead the EU for the 2024 - 2029 term.

**Commission adopts 2024 Enlargement Package** 

The European Commission's 2024 Enlargement Package highlights progress in EU accession efforts by potential candidate countries, including Albania, Ukraine, and Türkiye. This package emphasizes the geopolitical importance of EU enlargement as a strategy for promoting democracy, stability, and economic growth. Key advacements include Albania's and Bosnia and Herzegovina's progression in negotiations, Ukraine's continued reforms despite the ongoing war, and Kosovo's achievements in crime reduction and visa liberalization. The package also introduces economic growth plans for integrating future members more effectively into the EU framework.

The European Parliament has adopted a report on the 2025 budgetary procedure, focusing on the draft general budget for the European Union. This proccess includes negotiations and the presentation of a joint text between the Council of the EU and EU Parliament. The decision reflects the European Parliament's involvement in finalizing budget allocations and financial planning, ensuring transparency and strategic alignment with the EU priorities.

The European Commission adopted standa rds for European Digital Indentity (eID) Wallets, ensuring secure, interoperable tools for identification and data sharing across the EU, with strong privacy protections and broad use cases like tavel and payments. The initiative is part of the broader European Digital Identity Framework, expected to be rolled out in the end of 2026.
